



## Christian Berner Tech Trade AB (plc) acquires Fillflex AB

The technical trading company Christian Berner Tech Trade AB has signed an agreement for the acquisition of all shares in the filling company Fillflex AB, thereby strengthening its position within the liquid filling sector in the Nordic market.

Fillflex AB manufactures flexible filling machines for liquids and viscous products within the foodstuffs, pharmaceuticals and hygiene industries, in addition to chemical products. The company has four employees, is headquartered in Västra Frölunda, south of Gothenburg, and the annual turnover in 2015 was 14.6 MSEK.

 We have previously communicated that we are on the lookout for objects to acquire, and it feels good that we now carry out our first acquisition since our listing on Nasdaq First North. Fillflex AB has expertise and in-house developed technologies that complement Christian Berner's existing offer within the sector of liquid filling and packaging, says Bo Söderqvist, CEO at Christian Berner Tech Trade AB.

Fillflex AB has developed complete systems for all types of filling solutions. Fillflex will be gradually integrated into Christian Berner AB, with its current staff, during autumn 2016.

 It feels stimulating to start this collaboration with Christian Berner. The companies' business activities complement each other and will create some fine conditions for growth within the field of filling and packaging, explains Pär Nygren, CEO and owner of Fillflex AB.

Fillflex forms part of Christian Berner's Process & Environment Business Area as of July 2016. The acquisition is judged to have a marginally positive influence on Christian Berner Tech Trade's results per share.
